The President: "I wish to advise members that, in terms of clause 3.9 of the Constitution, Mr. H. P. Carlisle had been co-opted to serve on Council."

#### PAPERS FOR PRESENTATION

The President: "We have two papers today, and I am first going to call on Dr Stander the Head of the Water Division of the C.S.I.R., who is well known to many of you for his work and talks on pollution, who has had more than a little to do with this industry, and who has been I would say, of the greatest possible assistance to the mining industry in overcoming the problems of pollution which are so prevalent in industry of this nature. He, Mr Henzen and Mr Funke have written this paper, 'The disposal of polluted effluents from mining, metallurgical and metal-finishing industries, their effects on receiving water and remedial measures.' This is the Water Year, as you know, and it is most appropriate that we should have such an authority to talk to us on this very important topic. I now have much pleasure in asking Dr Stander to introduce his paper."

After the presentation of the paper the President said, "Gentlemen, I am sure that you would like me on your behalf, to thank Dr Stander very sincerely for a paper which I think has enabled us to get a completely new slant on the Water Year. There are many people who have put their finger on this campaign and said, it is all a gimmick. There are others—I suppose notably some of the bridge clubs which operate on week-day afternoons in Parkview—who seem to think that this is a quick way of getting early rain. Of course, it is not.

This is a most important paper which we have had given to us this afternoon. You probably found it here when you arrived and have not read it—I was very lucky to be able to read it last night, and there is an awful lot of meat in it. For as long as I have been associated with mining in any way, there has been a problem of polluted effluent—of effluents carrying a mineral load from mining, and I think Dr Stander is absolutely right—and, of course, the Commission is right when they say that this is not merely the problem of mine management or mine owners—this is a problem which affects every single human being in this country.

He has made some quite interesting comments, and I am sure there are going to be some interesting contributions. We have all seen the ravages of the acidic mine waters underground—Dr Stander mentioned effluents from open adit mines in Natal. I can well remember when I was a member of the Mines' Department staff, going out with some Government people chiefly to gather enough evidence to prosecute the manager of a colliery, who was letting water run into a public stream. He violently contested this and when we were there, produced half-a-dozen native pigs to drink the water to convince us of its purity. A photograph was taken of this and finally he duly ended up in Court. There was quite a furore when one of the lawyers got up and said, 'Your Worship, you will notice that in the foreground of this picture there are a whole lot of native pigs drinking this polluted water. The manager is also there, he is the one with his hat on.

Dr Stander, I think, has been generous in his tribute to the work done in the Chamber on this problem—in my time we have seen a lot of work done. He has mentioned some very interesting points which I am sure ought to receive further attention, and I note Mr Daneel here frantically writing these down—I hope that this is for further reference.

I think it is absolutely right that at the end of 1970, which is the Water Year, this Institute should have a man of Dr Stander's standing, to come and put these facts before us, for us to take home and ponder. You know, the real use of water is the reclamation of it, and you will hear people say that this country is so frightfully dry—that this is just a country without water. I heard facts today at lunch which astonished me and made me wonder whether we are not all a little blind in this respect, and whether we should not look a great deal further than our noses. Accept that it is a dry country, but accept that there are undisclosed subterranean sources of water which we should look for, and that we should use the evidence which is spread before us in a paper such as this, to make far better use of the heritage which is ours in the way of water.

Thank you very much indeed, Dr Stander."

Dr C. M. van Stander and A. B. C. Daneel then contributed to the discussion (these contributions will appear in a later issue of the *Journal*).

The President: "The next paper in our agenda will be a paper which was published in the June number of our *Journal*, this is, 'Manpower utilization in South Africa with special reference to the mining industries,' by Mr Hugh McGregor who, as you know, is Chairman of the P.E. Consulting Group. He is really a mining engineer who has seen—I was just going to say "seen the

light"—a mining engineer gone wrong, probably. He has been one of us for a long time. There are two things which Mr McGregor has very specially to commend him—the one is that he was among the original founders of the Witwatersrand University Mining Engineers' Association, which, in fact, saw the light of day or the light of late afternoon in the pub in this building, and then he was also a very leading light—in fact, the guiding light of St. Martin's School in this town. He really should need no introduction to any of you for his professional attainments, and I have great pleasure in asking him if he will introduce the paper which, as I say, has been published in our *Journal* and which you have all read with as much interest as I did."

After the presentation of the paper the President said:

"Thank you very much, Mr McGregor, for a paper which I am sure, gentlemen, you will find extraordinarily interesting and provocative. I know from the number of people who asked to contribute this afternoon, which is large, that a lot of people have been giving a lot of thought to this very much misused and very little understood word, productivity. I think that this paper and the discussion which will certainly follow, will be an important contribution to the literature on this subject, which in this country anyway has been fogged by all sorts of other considerations, particularly when you take the very first word in the title of the paper, 'manpower'. This is a word which has been very much bound up in this country with prejudices, with laws, with natural conditions, and with everything that has nothing to do really with the efficient sensible use of manpower. I think that we need what Mr McGregor mooted a moment ago, a special bureau to look into the utilization of manpower and the way our minds revolve round this particular concept.

I am not going to continue now because I know that the volume of contributions will point the interest which Mr McGregor's paper has aroused. Thank you very much for your paper."
